Areas of Practice

Crime

Giles joined Chambers as a tenant in October 2007 following completion of his pupillage at Tooks. Giles has a strong fraud practice, instructed in cases involving sophisticated Ponzi fraud schemes, multi-million pound credit card fraud and high-level benefit fraud.

Giles also specialises in cases involving serious sexual offences, including rape and offences against children. Giles is frequently instructed in courts martial at home and abroad. Giles has a particular interest in representing youths and individuals with mental health issues appearing in the Crown Court.

Notable Cases



Crown Court and Courts Martial



R v U and others [2012] Liverpool Crown Court

Giles is currently instructed as junior counsel in a complex fraud case, representing a dentist accused of a large-scale conspiracy to defraud the NHS.



R v Silcott and others [2012] Kingston Crown Court

Giles was instructed as junior counsel in a multi-handed robbery case, acting for a defendant accused of conspiracy to rob cash in transit vehicles.



R v Laurencin and others [2012] Snaresbrook Crown Court

Giles acted as junior counsel in a multi-handed case involving firearms and aggravated burglary.



R v Burns and Mussa [2011] Kingston Crown Court

Giles was instructed in a two-handed rape trial, successfully arguing that there was no case to answer against his client.



R v Moyo [2010] Colchester Military Court Centre
Giles represented a Zambian national, serving in the British military, charged with multiple counts of rape.

R v Mosthafir [2009], Wood Green Crown Court.
Giles secured the acquittal of a 38- year-old man charged with two counts of sexual assault of a 12-year old girl.

R v Curtin and others [2009], Kingston Crown Court.
In a high profile case, Giles represented a young defendant charged with a "smash and grab" robbery of £300,000 worth of jewellery from a leading London hotel.

R v Taylor [2009], Lewes Crown Court.
Giles represented a defendant serving a life sentence for murder, charged with making threats to kill following a visit to an ex-girlfriend's home whilst on day release from prison. Giles secured an impressive acquittal for his client in adverse circumstances.

R v Gnanakaran [2008], Southwark Crown Court.
Giles represented a Sri Lankan national charged with conspiracy to steal in a large-scale credit card fraud operation involving petrol stations throughout the South-East of England.

R v Patel [2008], Croydon Crown Court.
Giles acted as junior counsel in this high profile multi million pound credit card fraud trial, representing the computer mastermind behind the largest counterfeit credit card factory uncovered in the UK to date.

R v Casey and Davies [2008], Croydon Crown Court.
Giles represented two young women acting as "mules" in a case of large-scale cocaine importation from Brazil.

Appeal work

R v Blackshaw and others [2011] EWCA Crim 2312
Giles represented Lorri Anne McGrane, one of the appellants in the leading sentencing authority for offences committed during the civil disorder in August 2011.

R v Askew (Martin) [2010] EWCA Crim 2102
Giles represented the second and third appellants in an appeal against sentence in one of the high-profile Gaza protest cases. Giles successfully argued for a reduction in sentence for the third appellant.

R v Mouad Amri [2008] EWCA Crim 1350.
Giles successfully appealed against the imposition of a sentence of Imprisonment for Public Protection in a case of robbery and possession of an imitation firearm.

R v McLeod [2008] EWCA Crim 2980
Giles successfully argued that a custodial sentence of 18 months was manifestly excessive in a case of burglary and aggravated vehicle taking.

R v Manilal [2008], Court of Appeal, Criminal Division.
Giles successfully appealed against the length of an extended sentence in a case where the appellant had pleaded guilty to assaulting his 3- and 6-year-old sons.
