**R v Ali Saleem and Shakil** Kingston Crown Court – the 7<sup>th</sup> July tube bombings trial.



**R v Khyam** Central Criminal Court - the fertiliser bomb plot, longest ever terrorism trial.



**R v Sabeel Ahmed** Central Criminal Court - Glasgow Airport and 'Tiger Tiger' nightclub case. Failing to give information in terrorist case. Terrorism Act 2000 s.38B.



**R v Waris Ali** Leeds Crown Court - possession of articles for use in terrorism.



**R v Magee (Kathleen)** Sheffield Crown Court - failing to give information in terrorist case. Prevention of Terrorism Act 1976 s18.



### Criminal Appeal



**R v Flanagan (John Patrick)** [2005] EWCA Crim 2286 - fresh evidence appeal, murder false confessions and psychological evidence.



**R v Allali** [2006] EWCA Crim 636 - sentencing appeal, calculation of time served on remand.

**R v Christie and others.**(2009)1 Cr App R 36 - Birmingham gang shooting, murder, joint enterprise.

**R v O'Toole (Laurence)** [2005] EWCA Crim 1339 – sentencing appeal, extended sentences.

**Attorney General's Reference (Nos.21 and 22 of 2004)** [2004] EWCA Crim 3048 - sentencing of juvenile robbers, right of judge to give non custodial sentences where exceptional progress made.

**R v Wahby** Court of Appeal - inferences from silence in juvenile cases.

**Culpepper v Trinidad and Tobago** Privy Council - appeal from murder conviction.

**R v Austin (Nicholas)** [1996] 2 Cr. App. R. (S.) 191 [1996] R.T.R.- limitation on criminal compensation orders in uninsured driver cases.

### **Fraud/ Money Laundering**

**R v Le Roux & Hooper** - SFO case, rights issue share fraud, collapse of Norton Motor Co.

**R v JH** – international advance fee fraud.

**R v Littleton** – large scale building trade fraud.

**R v Singh** - long firm fraud.

**R v El Jamal** Southwark Crown Court - banking fraud

**R v Smith** Woolwich Crown Court - exchange bureau money laundering.

**R v Ghazi** Middlesex Crown Court - bank fraud and alleged terrorist funding.

**R v Ahmad** Hove Crown Court - Companies Act offences.

**R v Mabibi** Croydon Crown Court – organised car rental fraud.

### **Murder and Manslaughter**

**R v McNamara** Birmingham Crown Court – administration of heroin, manslaughter.

**R v Tully** Birmingham Crown Court – murder.

### **Serious Crime**

**R v Boyle** – attempted murder, contract killing.

**R v Hayden & Gilligan** – armed robbery bugging case. Gave rise to H and G v UK.

**R v Irfan** - massive scale heroin importation.

**R v Siddi** Kingston Crown Court – importation of cocaine and ketamine.

## Confiscation

**R v Williams (Errol)** – a leading case under Drug Trafficking Act on drug confiscation proceedings (2001) 2 Cr App R(S) 44.

**R v Anderson** - £19 million confiscation claim.

## Prisoners Rights

**R (on the application of Szuluk) v Governor of Full Sutton Prison** [2004] EWHC 514 [2004] A.C.D. 45 - prisoners rights to confidential medical correspondence.

**R (on the application of Roberts) v Secretary of State for the Home Department** [2004] EWHC 679 - judicial review of categorisation in denial of guilt lifer case.

## Extradition

**Usunta v Public Prosecutor of Dusseldorf** [2007] EWHC 1562 Admin – interpretation of Extradition Act 2003.

## Criminal Judicial Review

**Azzam v Epping Forest Justices** – time limits in social security prosecution.

## Police Actions (examples only)

**Brown v Chief Constable of Northumbria** Newcastle County Court – 6 Claimants. Case involving recall of aircraft and allegations of false imprisonment and unlawful search.

**Lane v Metropolitan Police Commissioner** - allegations of breaking of prisoner's leg in police station.

**Harry Cross v Chief Constable of Devon and Cornwall** – hunt saboteur case.
